

PLB is a public taxing entity, commonly known as a “Senate Bill 40 Board,” that enters into funding contracts with agencies that serve individuals with developmental disabilities in St. Louis County.

PLB invests over \$24 million in St. Louis County to create opportunities for people to thrive in the community and employment settings of their choosing.

Community Services focus on providing supports which enable individuals to successfully live in their home or the home of the natural family, and participate as members of the community.

Employment Services focus on providing supports which enable individuals to successfully work in the setting of their choice.

2020 ACHIEVEMENTS

Eastern Region Alliance

The Eastern Region Alliance was recognized by the East-West Gateway Council of Governments with the Outstanding Local Government Achievement Award for an “exemplary collaboration, partnership and regional initiative”

- Four local Senate Bill 40 Boards worked together to efficiently use taxpayer dollars and reduce administrative burden on service providers
- Over \$48 million invested in 82 agencies that provide quality services to over 10,000 individuals with developmental disabilities and their families
- Newly launched outcomes capture data that demonstrates services are making a difference in people’s lives

COVID-19 Response

- Approved virtual service delivery, ensuring health, safety and continued human connections for a population that is at increased risk of isolation
- Implemented emergency funding of over \$2.3 million to support agencies as they worked through the challenges of increased costs and decreased revenue

2020 IMPACT

- 4,905** people received supports to live and work in their community
- 1,755** participated in the community
- 1,429** families received temporary support
- 431** people lived independently in their own home
- 1,694** people were employed in jobs of their choice
- 332** people received employment training
- 273** received transportation to work



COMMUNITY SERVICES INCLUDE:

Independent Supported Living – home management skill development and self-advocacy

Support Systems – provides a break for family caregivers

Community Integration – inclusive community engagement and social skill development

Professional Services – supporting physical and emotional well-being for individuals and their caregivers

EMPLOYMENT SERVICES INCLUDE:

Employment Training – job exploration, skill assessment and training

Supported Employment – skill development on the job

Sheltered Employment – five Sheltered Workshops located in St. Louis County

Agency Supports – general operations, one-time funding, capital funding and emergency funding
