I. Call to Order

A quorum was present and due notice had been published. Mr. Malin called the meeting to order at approximately 3:40 p.m.

II. Board Action Items

A. FY'26 Proposed Funds and Employment Services Overview

Ms. Herschbach discussed the annual processes and activities that are used in preparing the funding recommendations, and reviewed the proposed investments, including the FY'26 service adjustments. Mr. Kaufmann reviewed the PLB Fiscal Policy, which guides how funds are allocated.

- B. Employment Services FY'26 Funding Recommendations
 - 1. Employment Training FY'26 Services

Ms. Wilson moved that the Employment Services Committee approve the FY'26 appropriations and associated conditions for the Employment Training services, from the Unassigned Fund for a total amount not to exceed \$2,386,391. Ms. McClendon seconded the motion.

Ms. Meyer provided an overview of the Employment Training Services. Agency representatives answered questions from the Committee.

The motion passed unanimously.

2. Employment Services FY'26 Services

Ms. McClendon moved that the Employment Services Committee approve the FY'26 appropriations and associated conditions for the Employment Services, from the Unassigned Fund for a total amount not to exceed \$6,160,542. Ms. Wilson seconded the motion.

Ms. Meyer provided an overview of the Employment Services. Agency representatives answered questions from the Committee.

The motion passed unanimously.

3. Employment Transportation FY'26 Services

Ms. Wilson moved that the Employment Services Committee approve the FY'26 appropriations and associated conditions for the Employment Transportation services from the Unassigned Fund for a total amount not to exceed \$2,186,234. Ms. McClendon seconded the motion.

Ms. Meyer provided an overview of the Employment Transportation Services. Agency representatives answered questions from the Committee.

The motion passed unanimously.

4. Agency Supports FY'26 Services

Ms. McClendon moved that the Employment Services Committee approve the FY'26 appropriations and associated conditions for the Agency Supports services from the Unassigned Fund for a total amount not to exceed \$2,427,957. Ms. Wilson seconded the motion.

Ms. Meyer provided an overview of the Agency Supports services.

The motion passed unanimously.

5. Partnership for Hope for FY'26

Ms. Wilson moved that the Employment Services Committee approve the FY'26 appropriation for Partnership for Hope from the Unassigned Fund for a total amount not to exceed \$200,000. Ms. McClendon seconded the motion.

Ms. Meyer discussed the Partnership for Hope and answered questions from the Committee.

The motion passed unanimously.

III. New Business

No new business was discussed.

There being no further business before the Committee, the Employment Services Committee adjourned at approximately 4:15 p.m.
