Ms. Herschbach provided an update regarding the change from POS to Reimbursement grant funding in FY'20, and the plans for returning to POS funding in FY'22. Agencies that experienced a negative financial impact due to the pandemic were allowed to temporarily change from POS to grant funding. All FY'22 services that were changed will be reviewed at least quarterly and are expected to be converted back to POS by January 2022.

1. Employment Training FY'22 Services

Mr. Wallace moved that the Employment Services Committee approve the FY'22 appropriations and associated conditions for the Employment Training services, from the Unassigned Fund for a total amount not to exceed \$2,403,947.

Ms. Kopff provided an overview of the Employment Training services.

The motion passed unanimously.

2. Employment FY'22 Services

Mr. Bolster moved that the Employment Services Committee approve the FY'22 appropriations and associated conditions for the Employment services, from the Unassigned Fund for a total amount not to exceed \$4,965,425.

Mr. Wallace seconded the motion.

Ms. Kopff provided an overview of the Employment services.

The motion passed unanimously.

3. Employment Transportation FY'22 Services

Mr. Wallace moved that the Employment Services Committee approve the FY'22 appropriations and associated conditions for the Employment Transportation services from the Unassigned Fund for a total amount not to exceed \$1,507,253.

Mr. Bolster seconded the motion.

Ms. Kopff provided an overview of the Employment Transportation services.

The motion passed unanimously.

4. Agency Supports FY'22 Services

5. Partnership for Hope for FY'22

Mr. Wallace moved that the Employment Services Committee approve the FY'22 appropriation for Partnership for Hope from the Unassigned Fund for a total amount not to exceed \$200,000.

Mr. Bolster seconded the motion

Ms. Kopff discussed the Partnership for Hope and responded to questions from the Committee.

The motion passed unanimously.

New Business

No new business was discussed.
